The Erie County Community Foundation is pleased to announce that it has recently received accreditation with National Standards for U.S. Community Foundations™. This accreditation indicates that the Erie County Community Foundation meets the highest standards for philanthropic excellence.

“This is a significant accomplishment,” said Mary Jane Hill, Board Chair. “When donors trust the Erie County Community Foundation with a charitable bequest, to establish a fund, or set up an annuity, they do it knowing that we have met rigorous standards for donor services, investment

Ohio's community foundations are local nonprofit organizations providing donors a simple, powerful and highly personal approach to giving—so their gifts do good works within the community, forever.

One hundred years ago, the community foundation concept was born in Cleveland Ohio, giving rise to a new philanthropy, a new way of participating in community, and a new vision for the future.

Today, there are more than 700 community foundations across the U.S. that invite ordinary citizens with a vision and a passion for community to create something together: For good. Forever. Nationwide, these organizations collectively manage more than \$48 billion in assets and make grants of approximately \$4.5 billion a year to improve life in their communities. This philanthropic model has spread beyond U.S. borders, with approximately 1,700 community foundations established worldwide.

“On the field’s 100th anniversary, we want to celebrate all the

good work being done by community foundations throughout America and especially right here in Ohio” said Dr. Susan T. Allen, Executive Director of Philanthropy Ohio. “In communities throughout the state, the generosity of countless donors and partner organizations continues to make life better for all of us.”

Thanks to community foundations, people in cities and towns throughout the State of Ohio can pool their charitable funds into community resources for the benefit of all. Community members from Cincinnati to Cleveland have literally given billions of dollars since Ohio’s first community foundation was established in 1914.

Community Links Seeks Interns

As of January 1, 2014, the Sandusky /Erie County Community Foundation officially changed its name to the Erie County Community Foundation.

When the Community Foundation began 17 years ago, the individuals, organizations, and private foundations that came together to establish a community foundation in Erie County were primarily located within the City of Sandusky. The original name of the Foundation reflected this fact.

In the years since its inception, not only has the Community Foundation grown in assets, but also in service area. Funding has been provided to organizations that serve every community in Erie County. Donors to the Community Foundation can be found throughout Erie County and beyond.

“The Board of Directors made the decision to change the name of the Community Foundation to more accurately represent the region we serve.”, said Anna Oertel, Executive Director of the Erie
